MESSAGE TO THOSE IMPACTED BY HATE

We recognize this is a very difficult time for you. It is important for you to know that the Hamilton Police Service (HPS) is here for you. Hate should not be tolerated in Hamilton. Our duty is to bring a resolution to the case by conducting a professional and thorough investigation and provide you with the necessary information and resources to assist and support you.

Enclosed in this resource guide is information on hate-related investigations, as well as support options available to you. It can be overwhelming to look at a list of organizations and phone numbers and you may be confused as to who you should call first. Please know that this is normal. The Victim Services Branch with the Hamilton Police Service is a great starting point to offer support and help you find the best service match for your personal needs and situation. They can be contacted 24/7 at 905-546-4904.

We hope that the information in this booklet helps answer some of your questions and provides you with options of where to call to obtain additional assistance and support during this difficult time.

VICTIM SERVICES BRANCH

Established in 1992, Victim Services is a Branch of the Hamilton Police Service. It is the only 24 hour crisis intervention service for victims of crime and/or tragic circumstance in the City of Hamilton.

We respond to the immediate needs of people who have been victimized by crime and/or experienced a traumatic incident such as homicide, suicide, sudden death, assault, domestic violence, sexual assault, human trafficking, **hate crime**, traffic, workplace or fire fatalities, robberies, and harassment, among other circumstances. Individuals, families, businesses and organizations receive critical crisis intervention as well as support, information, and referrals to assist them in healing from the short-term and long-term trauma of the incident.

Accessing support from the Victim Services Branch does not require police involvement or a formal police report be made. If you choose, we can assist you in navigating the reporting process, as well as provide support throughout the investigation and beyond, as there are no time limits to access support through our branch.

QUICK REFERENCE DEFINITIONS

Hate Crimes - are criminal offences where there is evidence to prove that the crime was motivated in whole or in part, because of a bias or prejudice, based on the victim's race, national or ethnic origin, language, colour, religion, sex, age, mental or physical disability, sexual orientation, gender identity or expression or any other similar factor.

Criminal Code Offences motivated solely or in part because of hate can include, but are not limited to: criminal harassment, utter threats, assault, assault with a weapon or assault cause bodily harm, aggravated assault, and mischief.

In order for police to lay a hate motivated criminal charge, there are two things that must first occur:

- 1) A criminal offence must have occurred (e.g. an assault, damage to property, uttering threats etc.).
- 2) Hate or Bias toward a victim must have motivated the criminal offence (e.g. because of the victim's race, nationality, ethnic origin, language, colour, religion, sex, age, mental or physical disability, sexual orientation, gender identity or expression, etc.).

Additional Hate Propaganda Criminal Offences: Advocating genocide, Public incitement of Hatred, Wilful Promotion of Hatred, Wilful promotion of Antisemitism.

Hate Incidents - Can include any incident that involves hate or bias towards any member of the public because of their race, national or ethnic origin, language, colour, religion, sex, age, mental or physical disability, sexual orientation, gender identity or expression, or any other similar factor. These incidents may not meet the threshold of a criminal offence, or be proven to have been motivated solely or in part because of the person's bias/prejudice towards the victim, but include some type of hateful overtone.



FREQUENTLY ASKED QUESTIONS

Reporting Options

Reporting hate motivated crimes and incidents are important in stopping the cycle of hatred and preventing others from being victimized. It is also important for police to be aware of hate motivated crimes and incidents, so that appropriate actions can be taken such as investigations and putting resources in place to make our communities safer.

* Please note - all reports are reviewed by Hamilton Police Service Hate Crime Unit. Online reports are not for emergencies as follow up can take some time.

Why should I report?

It is important that all hate motivated crimes or incidents are reported so police can investigate and develop proactive strategies aimed at reducing hate motivated occurrences.

We recognize some community members may not be comfortable attending a police station or reporting directly to a police officer. The online hate motivated offences reporting tool allows citizens to report these incidents without having to attend a station.

Hamilton Police want to hear from you.

How do Police determine if my incident will be considered a hate motivated crime?

Police must balance Constitutional Rights protected under the Charter of Rights and Freedoms with the Criminal Code of Canada (CCC), which can make investigations very complicated.

Hate Crime investigators will review each case to determine:

1. If this occurrence will be classified as a hate motivated crime or incident
2. Which identifiable group is impacted
3. If this occurrence is determined to be a hate motivated crime, then a request for a CCC 718.2 (a) (i) will be made, which requires the judge to take aggravating evidence that the offence was motivated by hate for sentencing purposes upon conviction

In some cases, police are required to conduct an investigation and provide documentation to the local Crown Attorney's Office to obtain consent from the Attorney General to lay any of the following charges:

Section 318 – Advocating Genocide

Section 319 (2) – Wilful Promotion of Hatred

Section 319 (2.1) – Wilful Promotion of Antisemitism



WHAT YOU MAY EXPERIENCE

Shock and Disbelief

You may actually feel shock and disbelief that something like this has happened to you, that someone else in your community has been hateful towards you.

Sense of Violation

Part of the shock of experiencing hate can be the sense of violation you may feel. This sense of violation can be emotional as well as involve financial loss if you have experienced property damage. Your privacy and sense of personal security and trust may feel taken away from you.

Anger and Frustration

Anger at those projecting hate is a very common feeling. You may feel frustrated because you are not able to express this anger directly at those who have engaged in hate. You may also feel frustrated and angry with the police and the court system, especially, if police have not been able to find the people responsible or lay a hate crime related charge.

Fear

After experiencing hate, you may feel that your home or community is not a safe place anymore. You may feel uncomfortable being alone. Many people fear that they will experience hate again. There can be supports available for you related to safety planning, counselling and community support.

Suspicion / Hypervigilance

Those that experience hate may find themselves suspicious about strangers, or hypervigilant about their surroundings. Police encourage citizens to phone the police about suspicious persons, activities or hateful behaviour.

Stress

After experiencing hate, you may experience a lot of stress and you may develop physical symptoms, such as difficulty sleeping or eating. Anxiety and fear can add to the stress. Connecting with a support system can be very helpful, such as family, friends, a doctor, or community agency you are connected with. You can also call Victim Services 24/7 at 905-546-4904 to explore support options.



FINANCIAL SUPPORT OPTION

Ministry of Children, Community and Social Services - Victim Quick Response Program+ (VQRP)

The Victim Quick Response Program+ (VQRP+) offers assistance following a violent crime. The goal of the program is to increase the safety of victims of violent crimes and help prevent re-victimization, as well as to lessen the impact through immediate support services.

Who may apply?

- ▶ A direct victim or immediate family member
- ▶ A parent or guardian of a victim who is under 16 years of age

Examples of Eligible Crimes:

- ▶ Homicide
- ▶ Attempt Murder
- ▶ Serious Assault
- ▶ **Hate Crime**
- ▶ Human Trafficking
- ▶ Sexual Assault
- ▶ Elder Abuse
- ▶ Intimate Partner Violence
- ▶ Child Abuse
- ▶ Criminal Harassment

Potential VQRP+ Support Options:

- ▶ Counselling
- ▶ Immediate Safety/Home Safety Items (e.g. locks, repairs, contact alarms)
- ▶ Basic Needs (e.g. clothing, hygiene items)
- ▶ Meals & Groceries
- ▶ Graffiti Removal
- ▶ Crime Scene Clean-up Services
- ▶ Interpretation Services
- ▶ Transportation
- ▶ Serious Injury Support
